The seventeen letters and emails received from Burston residents, fourteen of the letters were from residents West of the railway bridge on Burston Lane, representing 25% of residents on the Register of Electors, West of the railway bridge.

Of the twenty three signatures on the letter handed over at the meeting all but two were from residents West of the railway bridge on Burston Lane, representing 37% of residents from that area of Burston.

Of the seventeen letters or emails two were from residents who had not signed the joint letter.

The total number of written objections received was 25 which represents 8.6% of the Parish.
